Resilience is Key to a Clean Energy Future

As climate and cyber events become more severe, frequent, and costly, the resiliency of the energy grid remains a top priority for energy companies. How can energy regulators and companies ensure swift and efficient restoration of electric service following major disruptions? Panelists will discuss tools for hardening and adapting critical infrastructure systems to withstand major disturbances, best practices for governing network security and infrastructure networks, the importance of resilience planning and investing that prioritizes equity and environmental justice, the intersection of resilient grid infrastructure and reliance on natural gas, and the increased integration of long duration energy storage, advanced nuclear solutions, new gases, and hydrogen.

Reliability and a Transitioning Grid

Sufficient generation supply and grid infrastructure are vital to maintaining reliability. As global economic conditions, such as the war in Ukraine, continue to sustain supply chain issues and increase international instability, how can energy companies provide secure and reliable service while incorporating a variety of clean energy technologies and other renewable energy sources into the grid?

What is the future role of natural gas in this transition? Panelists will discuss these issues in the context of the clean energy transition and beyond. Panelists will also highlight the specific opportunities provided by recently passed legislation, including the IRA and IIJA, that aims to enhance the reliability of electric service for traditionally disadvantaged communities.

Workshop: Justice40 Initiative

On January 27, 2021, President Biden issued Executive Order 14008, entitled *Tackling the Climate Crisis at Home and Abroad*, which created the Justice40 Initiative. The Justice40 Initiative establishes a goal of flowing 40 percent of the overall benefits from climate and clean energy investments to disadvantaged communities. Investment categories include, among others, clean energy and energy efficiency, training and workforce development, and the remediation and reduction of legacy pollution.

The Department of Energy (DOE) is currently implementing Justice40 Initiative programs and funding opportunities. DOE funding opportunities are available through formula grant programs for state and local governments and competitive grant programs for companies and individuals. Attendees and panelists will work in groups to develop proposals focusing on either energy affordability, resilience, and reliability that can be utilized by either a state or local government or companies and individuals. The goal of the workshop is to ultimately develop proposals that will be submitted to DOE for consideration.
